Dear Al and Betty:

As we look forward to the next 75 years of ministry at Crescent Lake Bible Camp, we have some exciting opportunities before us but also some challenges.

With rising costs and decreases in gift and camper income, Camp can no longer operate as a summer-only ministry with a handful of winter youth camps and retreats. We need to find additional sources of income in the off-season for Camp to continue to exist.

In response to this challenge Crescent Lake Bible Camp created Northern Lakes Impact Center (NLIC) ([www.northernlakesimpact.org](http://www.northernlakesimpact.org)), a non-profit organization offering outdoor education programs to private and public schools. Establishing a relationship with schools helps Crescent Lake Bible Camp accomplish two key goals—the first is to generate income from September through May when Camp is essentially unused and the second is to create an outreach for un-churched school children to hear about and experience the ministry of Crescent Lake Bible Camp.

In order to launch NLIC, pay down current debt and raise operating capital for the next two years, we need your help. We have created the Crescent Lake Bible Camp Investment Fund to provide an opportunity for you to invest in the future of Camp. Your participation in the program will allow you to receive an interest rate on your investment that is more favorable than a bank-issued CD, while at the same time helping the ministry at Crescent Lake Bible Camp.

Listed below are the program details. Investors may choose their interest rate from .5% to the maximum listed.

#### Investment Fund Details

1. Interest will be paid quarterly by check or ACH (March, June, Sept., and Dec.)
2. Investors may choose their interest rate from 0% to the maximum listed.
3. The maximum total that will be allowed at 0-2.75% is \$100,000. When that amount is reached, no more investments for two years will be allowed. There is no maximum for any of the other, three, four or five years
4. Investment notes are backed by the \$12M worth of property Crescent Lake Bible Camp Owns.
